



Sec. 4. REPORTING PROCEDURE

A report shall be filed no later than January 15, 1969 to the executive and legislative branches of the state.

Sec. 5. APPROPRIATION

The sum of fifteen thousand dollars is appropriated to the governor's education planning and coordinating council for the purposes of this act.

CHAPTER 183

Senate Bill 1

AN ACT

RELATING TO STANDARD TIME; PRESCRIBING STANDARD TIME FOR THE STATE OF ARIZONA NOTWITH-STANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY BY THE UNITED STATES GOVERNMENT, AND AMENDING SECTION 1-242, ARIZONA REVISED STATUTES.

Be it enacted by the Legislature of the State of Arizona:

Section 1. Sec. 1-242, Arizona Revised Statutes, is amended to read:

1-242. STANDARD TIME

- A. The standard time in Arizona shall be the solar time of the one hundred fifth meridian west of Greenwich, commonly known as Standard Mountain Time.
- B. This section shall not be construed to affect the standard time established by the United States law governing the movements of common carriers engaged in interstate commerce or the time for performance of an act by an officer or department of the United States, as established by a statute, lawful order, rule or regulation of the United States or an agency thereof.

- C. Notwithstanding any other provision of law to the contrary by the United States government relating to adoption of daylight saving time by all the states, the state of Arizona elects to reject such time and elects to continue in force the terms of subsection A, relating to standard time in Arizona.
- D. The rejection of daylight saving time as provided for in this section may be changed by future legislative action.

Sec. 2. EMERGENCY

To preserve the public peace, health and safety it is necessary that this act become immediately operative. It is therefore declared to be an emergency measure, to take effect as provided by law.

RELATING TO BOATING AND WATER SPORTS; TRANS-FERRING TO THE ARIZONA GAME AND FISH COMIS-SION THE ADMINISTRATIVE POWERS AND DUTIES FOR THE REGISTRATION OF AND COLLECTION OF THE LICENSE TAX ON WATERCRAFT: PROVIDING FOR ENFORCEMENT; PROVIDING FOR ADMINISTRATION OF THE STATE LAKE IMPROVEMENT FUND BY THE ARIZONA OUTDOOR RECREATION COORDINATING COMMISSION; PROVIDING FOR CONSTRUCTION PRO-JECTS FROM THE FUND; PROVIDING FOR A WATER-CRAFT ADVISORY COUNCIL AND PRESCRIBING THE DUTIES THEREOF; AMENDING SECTIONS 5-301, 5-306.02, 5-306-05, 5-306.06, 5-306.07, 5-312, 5-313, 5-314, 5-315, 5-322, 5-323, 5-324 AND 5-325, ARIZONA REVISED STATUTES; AMENDING TITLE 5, CHAPTER 3, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 5-321.01, AND MAKING APPROPRIATIONS.
